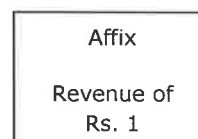

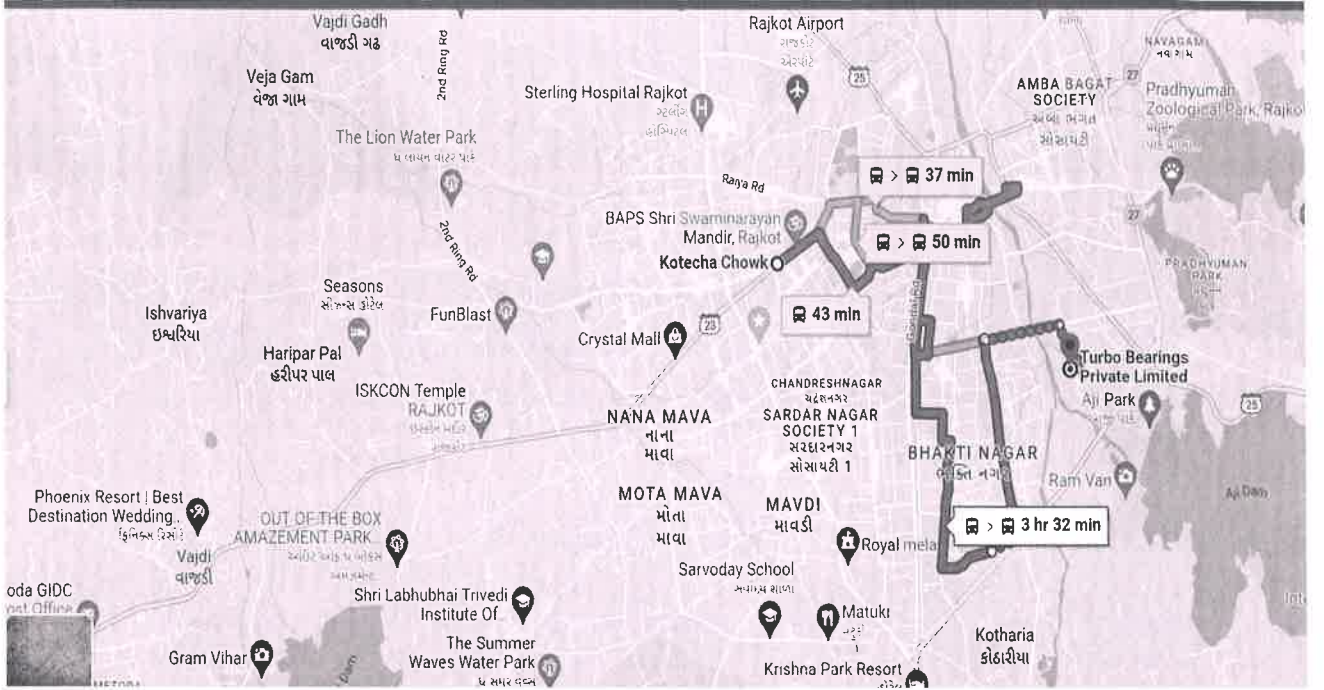

RESULT OF OPERATION AND THE STATE OF AFFAIRS OF THE COMPANY:

The Company is mainly engaged with Manufacture of various types of Bearing & Bearing Parts such as Tapered, Cylindrical, Needle Roller Bearings, Deep Groove Ball Bearings, Angular Contact Ball Bearings etc. Company's Bearings are well approved by various O.E. manufacturers of HCVs, LCVs, Cars, Three Wheelers, Tractors and general engineering products. TURBO bearings have excellent acceptability of performance in India as well as in International markets.

During the year 2019-20, Company has earned total Income of Rs. 5032.96 Lacs in comparison to previous year of Rs. 6478.16 Lacs. Company has export sales of Rs. 2472.91 in comparison to previous year of export sales of Rs. 3059.91 Lacs. Company has incurred Profit of Rs. 747.95 Lacs in comparison to previous year of Rs. 1071.28 Lacs in previous year. Looking at the financial

position during the year 2019-20, there is decrease in revenue, sales and profit but Management is working hard to maintain the growth and profitable position of the Company. In Furtherance, outbreak of covid-19 pandemic and consequent lock down in the last month of financial year 2019-20 may impact the operations of the Company in 2020-21, however Management is focusing and analyzing the impact of pandemic on the operations of the Business and hopeful to cope with the situations.

DIVIDEND:

Director do not recommend any final dividend for the Year. However, during the year, Board has declared and paid Interim Dividend of Rs. 3,20,00,000 i.e. at Rs. 40/- per share to those Equity Shareholders whose names appear in the Register of members as on 02/03/2020. Company has paid Rs. 65,78,790/- as Tax on Dividend.

TRANSFER TO RESERVE:

During the year ended on 31st March, 2020, the Company has not proposed to transfer any amount to General Reserve.

The Company has no Holding, Subsidiary or Associate Companies.

OVERVIEW OF THE INDUSTRY, EXTERNAL ENVIRONMENT AND ECONOMIC OUTLOOK:

As stated aforesaid, the Company is mainly engaged with Manufacture of various types of Bearing & Bearing Parts such as Tapered, Cylindrical, Needle Roller Bearings, Deep Groove Ball Bearings, Angular Contact Ball Bearings etc. The global bearing market size is estimated to touch USD 186.1 billion by 2025, registering a CAGR of 9.1% during 2014-2025. The Indian automotive bearing market in 2019, was valued at INR 70 billion, and is estimated to reach INR 156.8 billion by 2024, registering a CAGR of ~18%, between 2020 and 2024. The industrial segment is a major growth driver for the Indian economy. The Government endeavors to invigorate manufacturing and increase the sector's contribution to GDP.

The bearing market's growth is determined by various factors like surge in demand for PV, CV and 3W. It is also ascertained by elevation in the number of heavy, general and other industries and a larger demand from infrastructure growth, driving the market ahead. Bearings are extensively used in all the industries that require precision in dimension as a key to performance. The automotive sector constitutes a larger market demand share. But even then, the industrial bearings market is far more widespread with a higher number of applications.

In Furtherance, Manufacturing has emerged as one of the high growth sectors in India. The Gross Value Added (GVA) at basic current prices from the manufacturing sector in India grew at a CAGR of 5% during FY16 and FY20 as per the annual national income published by Government of India. The sector's GVA at current prices was estimated at US\$ 397.14 billion in FY20PE.

Hence, Future of the business of the company seems bright considering the demand in various sectors and viable environment of India.

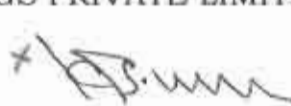

Opinion

(1) ACCOUNTING CONVENTION :

Financial statements are prepared under historical cost convention on accrual basis in accordance with the requirement of the Companies Act, 2013

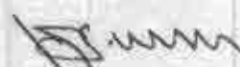
